

Dr. Jane Gillette first woman to lead MDA

MDA has elected Dr. Jane Gillette as its first woman President and will lead the Association for 2016 – 2017. Joining Dr. Gillette as new officers are Dr. Kevin L. Rencher, President-elect, and Dr. Andrew Althausen, Vice President. Dr. Doug Hadnot and Dr. Roger Newman were reelected as delegates-at-large by the MDA General Assembly in Helena.

In looking ahead for the year, Dr. Gillette says “My goal is to help all members succeed by working collaboratively with other MDA leaders, to build a healthy and resilient Association, which is prepared to meet the challenges and opportunities of the future.”

Dr. Gillette, a Bozeman general dentist, is a nationally recognized leader in oral disease prevention, health disparities, and evidence-based dentistry. She has served the ADA as chair of the Council on Access, Prevention, and Interprofessional Relations and spokesperson on Evidence-based Dentistry. She has also served as a leader with the National Network for Oral Health Access, the American Academy of Pediatric Dentistry, the American Association of Public Health Dentistry, and the National Institute of Dental and Craniofacial Research funded practice-based research networks.

Dr. Gillette serves as a member of the MDA Government Affairs Committee, immediate past chair of the Council on Public Health and Planning, and alternate delegate to the ADA House of Delegates. She holds a faculty appointment at the University of Washington and is the recipient of the 2015 ADA/American Association of Dental Research Evidence-based Practice Award. She is the key developer of both AbCd Montana and Montana's school-based sealant program, Sealants for Smiles!

Dr. Rencher is a pediatric dentist in Helena. He has served two terms as the Fifth District director on the

Montana oral health improvements reported

Children's access to dental care and dental visits by children in Montana have shown significant improvement, according to a report released by the American Dental Association Health Policy Institute.

The ADA report provides a state-by-state analysis of key oral health factors, including dental care utilization among children and adults with private dental benefits and among Medicaid children, sealant rates among Medicaid children, water fluoridation rates, self-reported oral health status, reimbursement rates for dental care services, and the dental workforce.

MDA LEADERSHIP

Nationally, the healthcare landscape has experienced dramatic changes. To a certain extent, the profession of dentistry in Montana has been sheltered from these changes; however, the environment is now changing more quickly than predicated. The source of these changes fit into two broad categories.

First, Health Care Reform has initiated system-wide changes in how healthcare is both delivered and paid for. As an example, health organizations are restructuring their care delivery systems into Patient Centered Medical Homes (PCMH's) and Accountable Care Organizations (ACO's), both of which include healthcare system redesign with the goal of reducing disease and controlling costs. In these models of care, PCMH's and ACO's are rated as to their quality and receive enhanced payments accordingly. Montana dentists are beginning to participate in these initiatives through participation in programs such as Medicaid "Meaningful Use", a state-wide electronic health record incentive program.

The second category of changes are related to the dental economy and workforce. Recovery from the Great Recession has been slower than expected which is exacerbated by a decade long trend in decreased consumer spending on dental services. Nationally, there

has been a steady decrease in insurance reimbursements, while at the same time there has been an increase in the number of payments made by Medicaid. With the opening of 15 new dental schools, there are now more dentists on the market. However, because of the weak dental economy, fewer practices are expanding associateship positions. The total average debt of new graduates is immense and will reach a predicted \$350,000 this year. Increasingly, new graduates are seeking employment in Dental Services Organizations or large group practices resulting in only 1 new graduate aiming to buy a solo practice for every 4 retiring solo dentists. Due to these complex factors, on average dentists are now practicing 8-10 years longer.

Exactly what these changes mean for dentistry in Montana is uncertain. As individuals we have little impact or effectiveness in monitoring and managing these changes. Our strength comes from our bond as dentists committed to our profession, and advocating and acting through our Association. There is no other association which will advocate for the interests of dentists. As such, I encourage all members to engage and advocate, even if the activity is small, because the actions that we take today will determine the opportunities of our future.

Medicaid update with Jan Paulsen

Dr. John Smith

I recently had the opportunity to sit down and visit with Jan Paulsen, the Dental Program Officer for Medicaid services in Montana and ask her a few questions about the new expanded Medicaid program. Jan has served as the Program officer for nine years and is highly regarded by dentists for her patience and considerable efforts to help improve the program.

Expanded Dental Medicaid has now been in effect for five months. How are things going? How many have signed up? Are financial resources holding up?

“It is going well, but there are some issues. The expanded program began quickly, so the new benefits could serve the people who qualified. Not all of the system updates were completed, so those Medicaid members eligible under previous qualifications were added during a second phase. Xerox is still working to provide verification of eligibility when patients arrive in your office via the web portal.

This work is not yet complete so you still have to call Xerox (1-800-624-3958) to verify benefits. The claims system is also 35 years old and is being upgraded. We at the state empathize with you and know that it is frustrating, but we ask for your patience and want to let you know the work will be completed and the system will be better.

Patients do not always understand their benefits and we appreciate any help your offices can provide to help explain the benefits if there are questions.

There are 42,800 Montanans signed up as of May 2016. Financial resources look good at the present time. The Federal government is obligated to pay for most of the program.”

Who makes up the Medicaid advisory group and what is its role?

“The group is selected to represent different areas of dentistry as well as different regions around the state. The current group meets quarterly and includes: Dr. Mark Rosebush (dentist), Billings; Remi Berube (denturist), Missoula; Dr. Reed Thompson (pediatric dentist), Kalispell; Dr. Tim Ballweber (orthodontist), Helena; Dr. Bernadette Wilson (oral surgeon), Whitefish; Kim Dunlap



"The improvements in oral health indicators for our children represent the commitment of dentists, dental hygienists and others to ensure the best oral health possible for Montana's children," said MDA President Dr. Jane Gillette.

"Innovative Montana oral health programs, such as Montana's Access to Baby and Child Dentistry (AbCd) and Sealants for Smiles! have increased prevention and needed dental care for infants, toddlers and school-aged children, said Dr. Gillette. "These programs are the result of strong partnerships between state government and non-profit organizations, and local community child advocates."

The ADA report shows that more Montana kids are getting dental care. The percentage of children with a dental visit in the past 12 months increased by 108 percent from 2000 to 2013 for children with Medicaid coverage and by 84 percent for children covered by private dental insurance from 2005 to 2011.

One of Montana's most significant oral health

performance measures is the percentage of dentists participating in Medicaid for Child Dental Services in 2014. Seventy-two percent of Montana dentists provide Medicaid services for children's oral health compared to only 42 percent in the nation as a whole.

The Montana Dental Association launched Healthy Smiles from the Start in 2015 to increase oral health awareness among expectant mothers and the parents of young children. Community programs and dental offices across Montana are participating in the public education campaign, which educates pregnant women on the importance of oral healthcare during pregnancy and urges caregivers to keep their children cavity-free by scheduling their child's first dental visit as soon as the first tooth emerges. Unfortunately, Congress was not in session during the week of our meeting, and our Senators and Congressman were back home in Montana. We did have the opportunity to meet with their staff members

to federal insurance plans, and the pending regulation requiring Medicare opt-in or opt-out for your senior patients to receive their prescription drug benefits (a bill is pending to permanently remove the requirement). All were well accepted, but the general comment from staff is that not much is going to happen with legislation during the balance of this session except the budget. We also took the opportunity to visit briefly about the recent regulations regarding restrictions on opiate prescriptions and how they can adversely affect those of us in rural areas.

"The MDA lobbying team does a great job. We have developed relationships with our members of Congress and their staff, and they remember us. MDA advocacy extends to in-state activities as well. We are active on

both sides of the aisle, and all of the folks who were in Washington DC also participate in various political activities in their local communities, both Democrat and Republican. I encourage all MDA members to get involved. "If you don't attend the dinner, you may find yourself on the plate." – *Doug Hadnot*

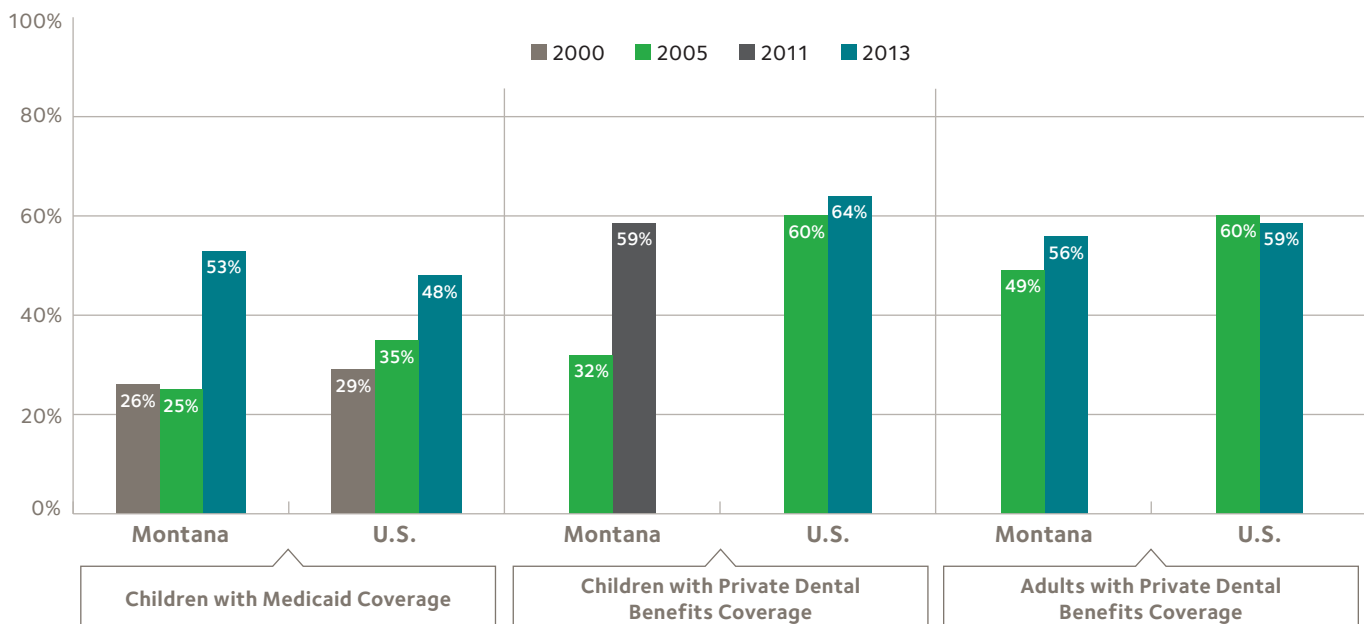

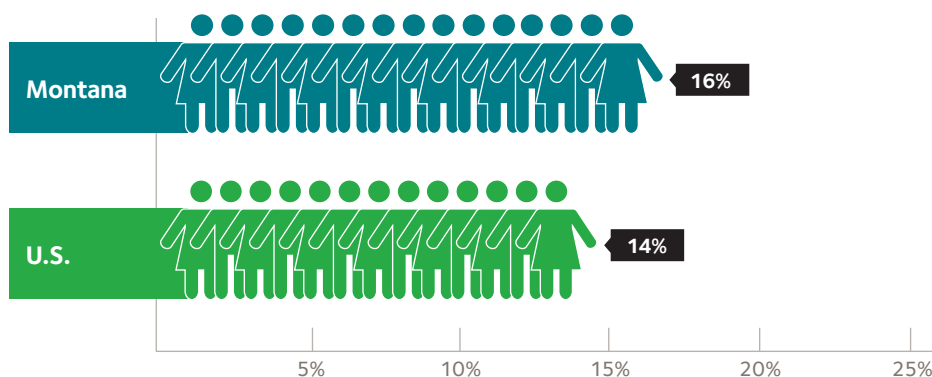

Percentage of Medicaid Children Who Received a Sealant on a Permanent Molar in 2013

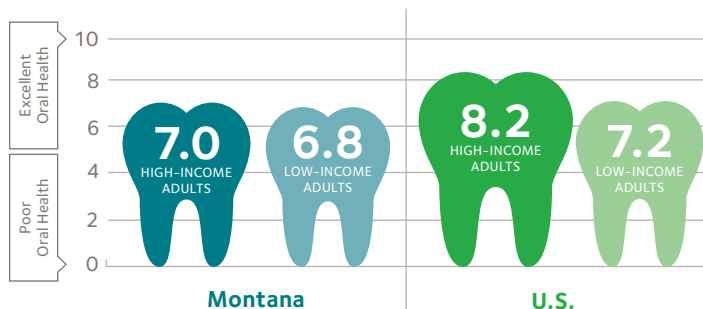

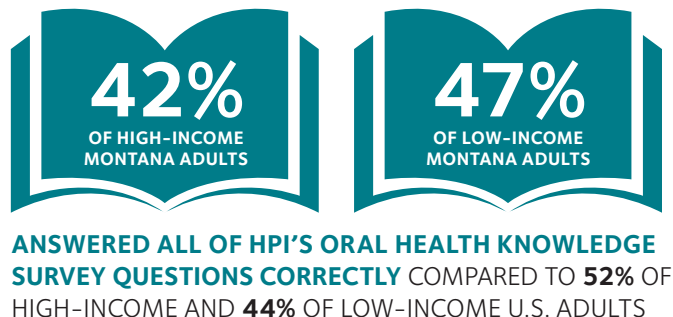

Oral Health Status Index Among Adults in 2015



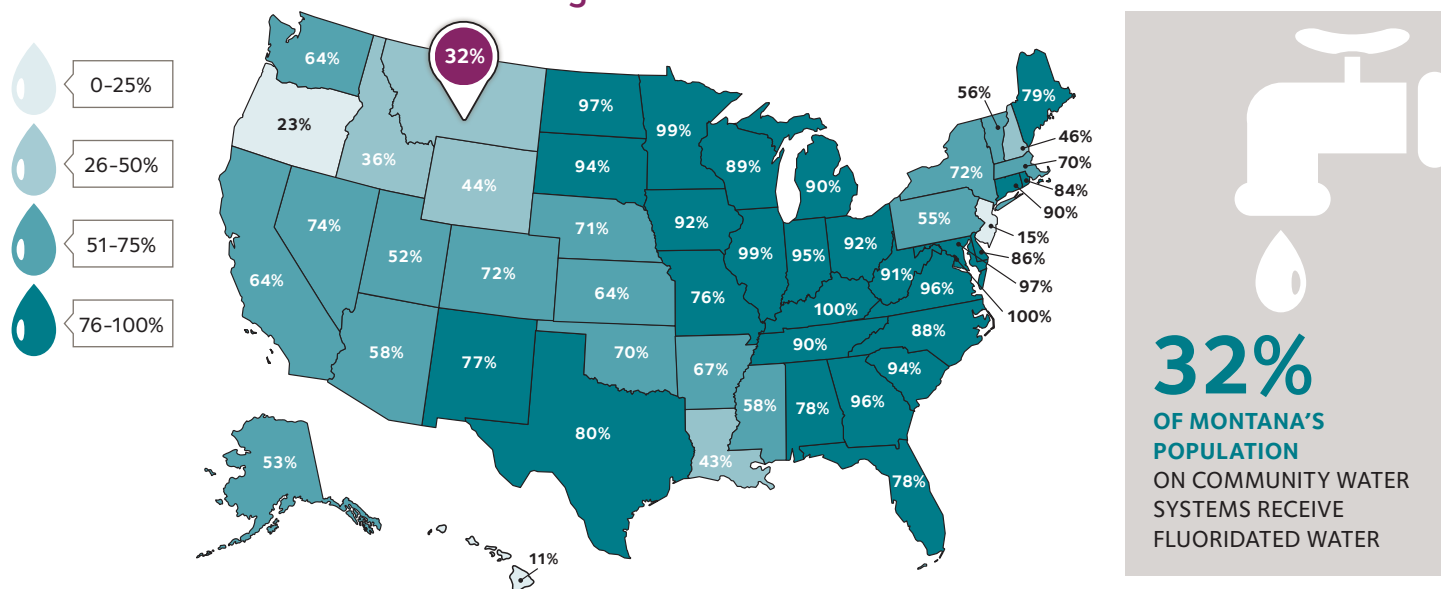
Oral Health Knowledge Index Among Adults in 2015

Percentage of Population on Community Water Systems Receiving Fluoridated Water in 2012

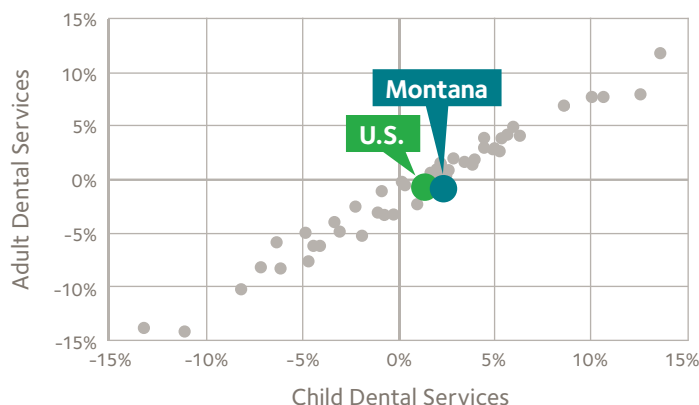

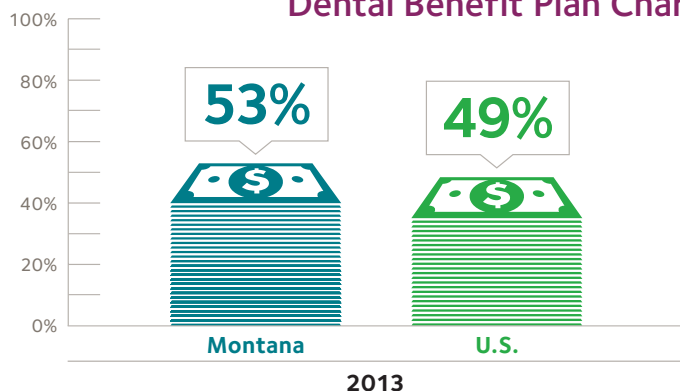
Change in Private Dental Benefit Plan Charges Between 2003 and 2013

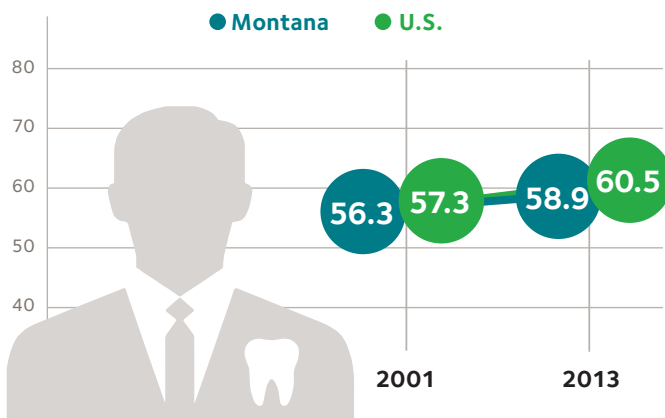


Medicaid Fee-for-Service Reimbursement as a Percentage of Private Dental Benefit Plan Charges for Child Dental Services

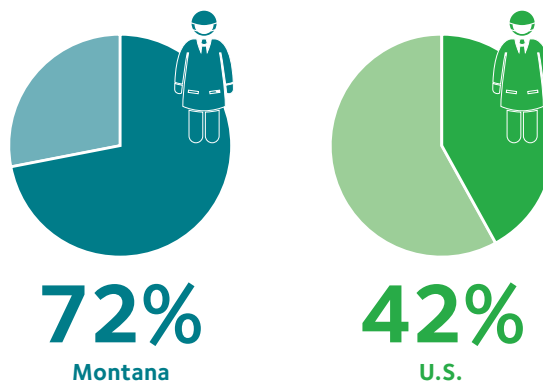
