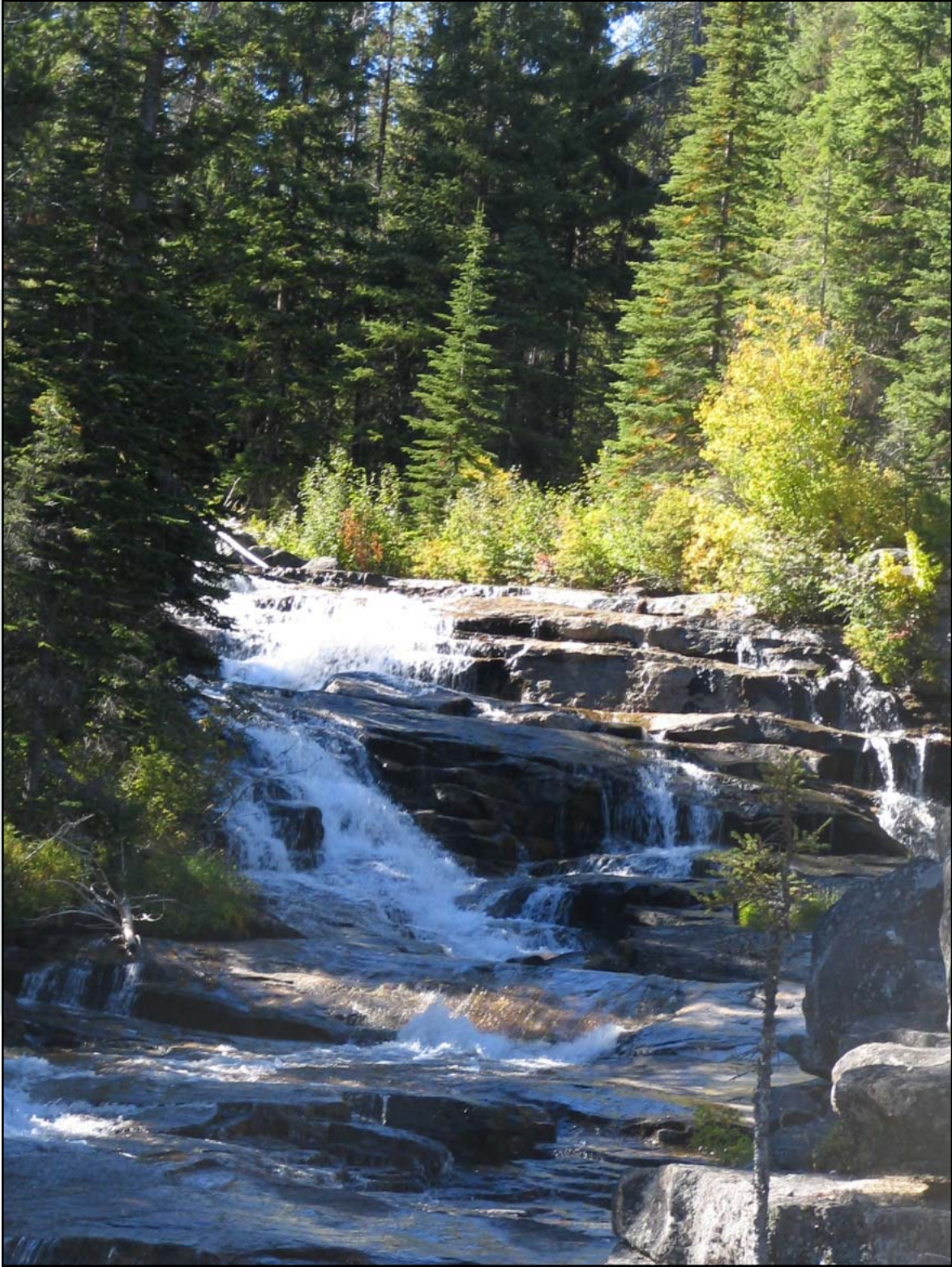

Michael C. Fling, DDS

"Providing Dental Care with Aesthetic Priority, Architectural and Biological Integrity" 6 CDE hours

Dr. Fling began his career in dentistry in 1976 as a laboratory technician.

Graduating from Oklahoma University College of Dentistry in 1984, he received the "Young Dentist of the Year Award" in 1988 from the Oklahoma Dental Association.

Maintaining a private practice with an emphasis on restorative dentistry, he has served as Course Director and Clinical Assistant Professor in the Department of Fixed Prosthodontics at the O.U. College of Dentistry. He is the founder and President of "Fling Seminars", providing advanced dental education to dentists, dental teams and technicians throughout the country.

Dr. Fling is also on staff with the Advance Education in General Dentistry (AEGD) residents at the O.U. College of Dentistry, lecturing on restorative concepts and technical excellence.

He recently completed the process to be awarded the title of "Pankey Scholar." As a member of the American Academy of Restorative Dentistry, the American Academy of Fixed Prosthodontics, and the American College of Dentists, he has lectured throughout the country to dental and laboratory associations and to various study groups on fundamental principles of restorative dentistry and achieving technical excellence.

Course description

This presentation demonstrates the need to blend what "looks good" with functional and biologic considerations. Reviewing a

treatment sequence that begins with the patient's aesthetic demands, techniques are reviewed that help determine what is aesthetically practical. Then, consideration is given as to how aesthetic priority can and should coincide with occlusal and biological integrity, as resultant occlusion and bite patterns play a direct role in restorative predictability. Practical clinical solutions will be given for different occlusal dilemmas along with optimum treatment sequence. Finally, discussion will be given to keys that create relationships in which the patients value a higher level of care, rather than "drill and fill" dentistry, so that they even ask for optimum dental care.

Dr. Allen earned his degree from Oregon Health Sciences University and completed the Army Advanced Education Program in General Dentistry in 1991. Dr. Allen received his Mastership in the Academy of General Dentistry and is currently an endodontic article reviewer for "General Dentistry". He is a published author and lectures throughout the world. After a successful career in the military, he joined a group practice in Salem where he continues to pursue his avocation of evidence based dentistry with an emphasis on endodontics.

Course description

This course is designed specifically for the endodontic practitioner who is seeking to overcome shortcomings in many of the traditional instrumentation, irrigation, and obturation techniques currently available in endodontics. Tips, tricks, and solutions will be presented that will make endo accessible for any clinician who wants to approach endo with confidence.

Topics covered will include:

Reducing separation anxiety with the latest developments in SAFE and flexible NiTi rotary instrumentation; virtually eliminating the risk of sodium hypochlorite accidents via SAFE apical negative pressure irrigation; achieving a lasting seal with carrier-free obturation and warm vertical compaction; and practice building - keep many of the cases you'd normally refer out.

Education Objectives

Scientific material and research data will be presented that will form the basis for understanding the next generation of safe and predictable endodontics. New technology has not only revolutionized the world of endo, but has also made it more accessible to practitioners of all skill levels. Upon completion of the course, participants will understand the concepts of working width, thorough apical cleaning, apical negative pressure irrigation, and microbial control.

"Functional Outcomes Following Treatment for Head and Neck Cancer" - Luke Buchmann, MD

Summary: At the conclusion of this presentation the participants will have an appreciation for importance of a good functional outcome following treatment for head and neck cancer. Specific areas to be cover are speech and swallowing outcomes, aspiration management, and review of quality of life studies in this cancer population. In addition the participant will understand how advanced reconstruction methods impact on post-surgical functional outcomes

"Oral Cancer Prevention and Early Detection: The Crucial Role of the Dental Professional" - Brandon Bentz, MD

Summary: In this presentation, the participants will be taught about the problem of head and neck cancer, the impact of prevention and early detection, and the role of the dental professional in contributing to improving the survival outcomes for these types of cancer. Finally, this presentation will review a comprehensive oral cancer screening examination that can be easily incorporated into a routine dental visit

"Oral Cavity Reconstruction Following Tumor Ablation" - Jason Hunt, MD

Summary: Resection of oral cavity carcinomas can leave the patient with significant functional and cosmetic disturbances. This lecture will demonstrate methods of oral cavity reconstruction to improve function and cosmesis. It will also discuss dental restoration following oral cavity reconstruction.

Dr. Eddy earned his MD degree from the University of Cincinnati in 1978, and completed advanced training in general and cardiothoracic surgery at the University of Washington. He moved to Missoula in 1992 and participated in the founding of the International Heart Institute at St Patrick Hospital.

After suffering a severe hand injury that abruptly ended his surgical career, Craig earned his JD degree from the U of M Law School and post doctoral law degree in health law from Loyola University Law School in Chicago. He joined the law firm of Garlington, Lohn, & Robinson in 2007, concentrating in the area of health law, especially legislative, transactional, risk management, regulatory, and liability issues.

Larry Riley received a bachelor's degree in political science from the University of Montana in 1963 and a JD degree from the U of M School of Law in 1966. He joined Garlington, Lohn & Robinson in the fall of 1967 and became a partner in 1973. He practices as a trial lawyer with a special emphasis on medical legal matters. Larry has tried numerous jury trials throughout Montana in both state and federal courts and enjoys an "AV" rating in the Martindale-Hubbell Law Directory. He also has served as a guest lecturer at the U of M School of Law since 1967 to the present time.

This class will cover a multitude of medical legal issues that arise in operating a dental practice. They will review the types of civil lawsuits or legal issues a dental office might encounter, including employee lawsuits, dental malpractice, and regulatory issues.

More importantly they will explain the best ways to prevent a lawsuit against your dental practice. They will discuss why effective communication between dental professionals and patients is so important. They will explore how to avoid wrongful discharge claims and discrimination claims, including age and sexual harassment claims. They will explain the medical legal process, including how the Montana Medical Legal Panel works. They will discuss the issue of dental malpractice, the importance of good charting, and effective documentation. They will provide examples of poor charting and pitfalls in charting and how to effectively create electronic medical records.

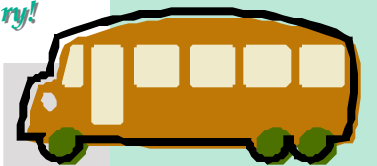
