

Montana Dentist Enters State House Race

ADPAC and MODEPAC Endorse and Encourage Support

Dr. Jane Gillette's name will appear on Montana's November 6 ballot as the Republican candidate in House District 65 (southwest Bozeman). Dr. Gillette was unanimously approved by the Gallatin County GOP Central Committee on July 30, 2018, after answering more than 20 detailed questions in person. HD 65 is currently held by Jon Knokey (R) who won an unexpected victory over Chris Pope (D) in 2016.

Knokey was a supporter of key legislation for MDA last session, and many were surprised by his withdrawal announcement. His employer promoted him to a position that requires significant international travel; as such, he could not commit to serving in the 2019 legislative session. Knokey withdrew from the race after the primary election so the Gallatin County GOP could find a strong replacement candidate.

Dr. Gillette earned her BS from Pacific Lutheran University and her DDS from University of Washington. She also completed her MPA from University of Montana and completed advanced courses at Harvard and Wharton Schools of Business. She started out as a dentist in the U.S. Air Force at Malmstrom Air Force Base in Great Falls, then became the dental director of Community Health Partners in Bozeman, then purchased a private dental practice. She currently serves as executive director of Sprout Oral Health in Bozeman and does consulting and speaking nationwide.

"Deciding to run for this seat was not an easy or quick decision," said Dr. Gillette in a telephone interview, "But I'll have the support of my family, and I've assembled a solid team that helped create a comprehensive campaign plan." Dr. Gillette has reset much of her work calendar to create time to campaign door-to-door in the district. Dr. Gillette also has the full support of Jon Knokey, who volunteered as her campaign treasurer.

Dr. Gillette's campaign website is janeforbozeman.com and includes a 30-second TV ad on the homepage. Montana individual campaign contribution limits for a

statewide race is \$180 per person or \$360 per couple. MoDePAC funded a PAC contribution of \$180, and ADPAC distributed a message to its members nationwide, asking individuals to financially support her race.

Montana Board of Dentistry Announces Settlement of Denturist Lawsuit

In 2013, the Denturist Association of Montana sued the Board of Dentistry, challenging, among other claims, the legal sufficiency of Rule J (Cause Number ADV-2013-924 in the First Judicial District Court, Lewis and Clark County), which prohibited Montana denturists from fitting prostheses over implants. On August 3rd, 2018, after the case had been heard by the Montana Supreme Court, the Montana Board of Dentistry accepted an offer by the Denturist Association of Montana to settle the lawsuit. The following terms were accepted as offered:

The Montana Board of Dentistry will sunset the current language of Rule J within 18 months of the signing of a court order dismissing the lawsuit with prejudice in exchange for implementing new rulemaking regarding the issue. The rule currently reads “The board [Montana Board of Dentistry] defines “unprofessional conduct” as follows: ... (j) fitting, attempting to fit or advertising to fit a prosthesis on or over a dental implant.” Before the 18 months have passed, the Board will promulgate a new rule regarding the ability of denturists to fit prostheses on or over a dental implant.

No specific replacement language was agreed to. Instead, whatever rule language the Board ultimately adopts will replace the current rule, effective before the sunset date. The Board accepted the settlement offer in consideration of both its overriding obligation to the protect public health, welfare, and safety from harmful practices, but also mindful of its obligation to permit the practice of dentistry, so long as a specific practice in question is safe. As always, safe practices regarding the fitting of prostheses by denturists will be the primary concern of the future rulemaking. The Court entered judgment in accordance with the settlement agreement on August 23, 2018, setting the sunset date as 18 months from that date.

During the rulemaking process, the Montana Dental Association and its members will have the ability to comment or otherwise participate in the same way as other stakeholders and/or members of the public. The Board of Dentistry is seeking substantive input from stakeholders, including the MDA.

MDA Executive Director Testifies at DPHHS Listening Session

On August 1, 2018, the governor's budget director, Dan Villa, and the director of DPHHS, Sheila Hogan, conducted a listening session to hear from providers with suggestions relating to the restoration of DPHHS funds due to a revenue surplus. MDA's executive director, Al Garver, testified as follows:

I'm here on behalf of 500 dentists in the Montana Dental Association, more than 2/3 of whom are certified Medicaid providers. Montana has one of the highest Medicaid dental provider participation rates in the country, and these professionals want to help this vulnerable population.

Relating to today's discussion and the funds being redirected back to DPHHS, we believe the highest

priority is the restoration of dentures for seniors. We have had a positive ongoing dialogue with DPHHS and believe they share that same goal.

For the next biennium, we reiterate our belief the Medicaid reimbursement rates are so low, that many dentists have to set limits on how many Medicaid patients they can accept. By increasing the dental reimbursement rate by a fairly small percentage, more dental providers would be able to see significantly more Medicaid patients.

Dental professionals hope to work with the state in any manner they can to continue to increase access and the number of Montanans served.

Children, Families, HHS Committee Recorded Six Hours of Public Comments

On August 6, 2018, the Interim Committee on Children, Families, Health and Human Services held a meeting to provide an update on the state revenue picture. Committee chairs Senator Mary Caferro and Representative Robert Lenz explained that they had no legislative authority over how DPHHS utilizes restored funding, but they wanted to provide a formal meeting to capture comments from providers and patients. Dozens of people lined up for testimony and the four-hour meeting was extended to six hours to accommodate all testimony. While the MDA prepared formal remarks, several quotes from testimony from other organizations were noteworthy.

"One thing that I will mention that isn't in senior long-term care, and I would be remiss not to mention it... is dentures. That is important to anybody! If you're an elderly person in a nursing home, chances are that your nutritional status is very compromised. You have all sorts of things going on, and to not have dentures so you can chew your food, eat properly, and maintain what dignity and health you have, is just amazingly sad. That obviously needs to be fixed, and should be a priority, and never should have happened to start with

and should be a priority now." —**Rose Hughes, RMS Management Services**

"To sit here and say, 'oh, we're so grateful for the provider restoration cuts'... I feel kind of hypocritical. Because those cuts should never have happened. As providers, yes, we're thankful we get another 3%, but that still means no provider rate increase this year or next year, and it compounds year after year in the budget process." —**Joel Peden, Montana Independent Living Project**

"Seniors in care facilities, many times don't have the funding to get dentures, and this continues to lead to a blended soft food diet with weight loss and other health issues. One facility we serve is the Montana Veterans home in Columbia Falls. When you see your patients doing well, and then they're moved to a soft food diet which means blending their food into a milkshake... they're usually not there much longer. With Montana Medicaid not covering dental crowns, recipients are forced to have infected teeth extracted. Because many cannot afford the cost of dentures, they often choose to

Second Lawsuit Filed for Non-Transparent Process in Medicaid Cuts

On July 31, 2018, disability rights advocates and Medicaid providers from across Montana sued the state, alleging that cuts to Medicaid reimbursement rates imposed by the Department of Public Health and Human Services are illegal and put Montanans with physical and mental disabilities at serious risk of institutionalization. MDA is a supporter of this lawsuit, but was not initially listed as a plaintiff.

The lawsuit was filed in state District Court in Helena, and plaintiffs include organizations that serve Montanans with developmental disabilities, mental illness and serious physical disabilities, as well as individuals who receive services through those providers. The lawsuit is the second filed this summer in state District Court against the state and the department over Medicaid cuts that were initially the result of actions by the 2017 Legislature. In June, the Montana Health Care Association, which represents nursing homes and assisted living centers, sued the state and the department over the cuts.

Last summer, the department proposed cuts to Medicaid reimbursement rates of 3.47 percent, arguing the move was necessary to implement budget cuts included in Senate Bill 261. The department later reduced those cuts to 2.99 percent. But while initially saying they would last for only a matter of months, the department then decided to extend the cuts through fiscal year 2019.

The plaintiffs argue that the cuts were made in an “arbitrary, unlawful and unconstitutional manner,” including by improperly targeting the cuts to community-based services for those with disabilities.

“The Department failed to follow almost every

requirement of the Montana Administrative Procedure Act in proposing the rate cuts,” the lawsuit states. “The rule-making notices of the cuts to Medicaid rates proposed by the Department in late June 2017 were not based on information in existence at the time of the cuts, but were done ‘in anticipation’ of such information. They were not supported by any official documentary or fiscal evidence.”

Although Gov. Bullock announced in late July that surplus revenue would be used to “backfill” economic losses, the lawsuit notes that legal action, including a temporary restraining order against the state, is still necessary because it remains unclear when or how the rates will be restored, or how programs will be refunded since the cuts were implemented in January 2018. The lawsuit was filed along with an application for a temporary restraining order to restore the cuts while the lawsuit went forward. That restraining order was granted August 2, 2018.

On the day after the lawsuit was filed and the day before the restraining order was granted, the State had proposed new rules to raise rates as of September 1, 2018. However, late last week, the State withdrew those rules and canceled the rulemaking hearing on these increases which was scheduled for August 30, 2018. However, in the notice, the State did provide that it would engage in rule-making in the future, with the intent of restoring the rate cut retroactively to July 2, 2018.

The case is scheduled for a September 20, 2018 hearing regarding the restraining order. It is scheduled at the same time as the hearing for the Montana Health Care Association noted above.

Montana Legislature Offers Page Program to Students

The Montana Legislature offers a unique opportunity for young people to participate in the legislative process through its Legislative Page Program. Page applicants are juniors and seniors in high school who are at least 16 years old. Pages perform a variety of duties under the supervision of the Page Supervisor. Their duties include assisting legislators and House and Senate staff by running errands, delivering messages, and distributing bills, amendments, and other official documents. Pages also have the rare privilege of working on the floor of the House or Senate in the midst of legislative action.

Pages serve for one week and are paid minimum wage. Arrangements and expenses for housing and transportation are the responsibility of the student and

his or her parents. The work week extends from 8:00 a.m. Monday to the close of Saturday's floor session. During the week, pages have the opportunity to meet the Governor, Secretary of State, and other high-level officials.

Pages must fill out an application and be recommended to serve by a Representative or Senator. Representatives may each recommend two students to serve during a legislative session, and Senators may recommend one student and one alternate. Page designations are processed in the order received.

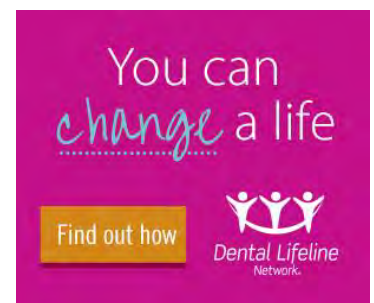
The DDS program restores the oral health and often transforms the lives of the patients we serve, like 65-year-old George who lives in Helena and has developmental disabilities and speech challenges. George had severe dental problems: he was missing several teeth and those that remained were decayed and broken. While he works one day per week as a custodian, he did not earn enough to afford the extensive dental care he needed. Fortunately, he was referred to the DDS program and he applied for help. Two generous volunteers agreed to come to his aid: a general dentist and a lab. Thanks to this kind team, George received thousands in donated care that he could not afford on his own. He wrote to express his appreciation for this amazing gift. *"It's great! I don't have any more toothaches. Dr. A. and his staff were always polite and courteous to me."*

In 1997, the Montana Dental Association partnered with Dental Lifeline Network • Montana in developing a Donated Dental Services (DDS) program to help people with disabilities or who are elderly or medically fragile and had no other access to dental care.

Thanks to Montana dentists and labs, and the financial support from Montana Public Health and Human Services, 1,339 people have received over \$4.6 million worth of comprehensive donated treatment since 1997.

She receives and evaluates patient applications, works with dental offices, provides specialist and laboratory referrals, coordinates all appointments and logistical needs, maintains program records and most importantly works to ensure that volunteers have a positive experience.
