

## MDA bills move forward

**W**hen the Legislature recessed for its “transmittal break” on March 1, two bills put forward by MDA were on their way to being enacted. Senate Bill 129, sponsored by Sen. Mary Caferro (D-Helena) will require third-party payers to reimburse dentists for covered services, such as diagnosis, when delivered remotely through telemedicine. The bill passed the Senate 49-1. Senate Bill 82, sponsored by Sen. Albert Olszewski (R-Kalispell), sets reasonable and fair standards for Medicaid overpayment audits. The Senate approved the bill 50-0. Both bills were passed by the House Human Services Committee and now await floor action in the House.

### **Hygienists to prescribe**

Action is pending in the House on SB 120, a bill to allow dental hygienists to prescribe topical fluorides, anti-microbials and topical anesthetics and to administer local anesthesia under general supervision. It passed the Senate 50-0 after being amended to allow prescriptive authority only under general supervision of a dentist and with limits on the types of drugs that can be prescribed. As introduced, the bill had no such requirements. These

provisions are similar to those in four other states that allow hygienists to prescribe, but will be opposed by the Montana Dental Hygienists Association, which asked Sen. Nels Swandal (R-Wilsall) to sponsor the bill.

### **Other MDA bills stalled out**

Two other MDA legislative proposals fell short. Senate Bill 80, sponsored by Sen. Steve Fitzpatrick (R-Great Falls), would have allowed dentists to delegate some functions to dental assistants under general supervision of a dentist. The bill was tabled in the Senate Business, Labor and Economic affairs Committee after the committee placed adverse amendments on it.

MDA did not pursue legislation to require insurers to pay for general anesthesia as needed for dental treatment of young children and the disabled in hospitals and other



## Task force proposes amendments to Bylaws

**Dr. Doug Hadnot, Chair, Constitution and Bylaws Review Task Force**

The Constitution and Bylaws Review Task Force is again recommending changes to our governing documents. As you may recall, last year the General Assembly approved a comprehensive reorganization and rewrite of our Constitution and Bylaws. Last year there were no major changes in content, but this year we are proposing some more substantial changes to bring the document more up to date with current practice, and streamline the organization. The Board of Directors is

in the process of reviewing our recommendations, which will then be posted to MDA's website.

The proposed amendments will be offered as separate resolutions. Each can be accepted, rejected, or modified by the General Assembly at the May 4 meeting in Missoula. Several of the resolutions deal with the duties of officers. We have also recommended that the Alternate Delegates to the ADA be nominated by the Constitution, Bylaws and Nominating Committee, and that the membership be notified of all nominations for officers 60 days in advance of the General Assembly.

We are proposing some significant changes to our committee structure including sun-setting four committees – Dental Benefits, Insurance, Annual Sessions, and Health & Well-Being will be eliminated. The Annual Sessions duties will be added to the CE Committee. The name and duties of the Technology Committee will be expanded to include Communications and the Council on Dental Health and Health Planning will assume new duties related to Access and a name change as well. We are recommending the establishment of a new Membership Committee and the addition of three members to the Constitution, Bylaws and Nominating Committee. Other minor changes are proposed to the duties of several committees and redundant language has been removed.

We are proposing a revision to the order of business of the General Assembly, and another to allow for calling a Special Meeting of the Assembly in case of an emergency. There is also a proposal to allow the Board to appoint Officers, Delegates and Alternates to fill vacant positions until the next meeting of the GA.

There is a proposed resolution to define Special Committees or Task Forces, and one to further define the duties delegated to the Executive Committee between meetings of the Board. Last but not least, Resolution

operating room facilities. The bill was thwarted by a provision of the Affordable Care Act that requires states to pay for new mandated benefits.

### Fee “Transparency”

Three bills addressing transparency in health care fees are working their way through the legislature. SB 96 sponsored by Sen. Cary Smith, (R-Billings), HB 400 by Rep. Greg Hertz (R- Polson) and HB 123 by Rep. Amanda Curtis (D-Butte) all will require health care providers to give patients on request estimated fee information prior to delivery of care. Insurers would also be required to give coverage information to patients prior to treatment. A fourth transparency bill sponsored by Sen. Ed Buttrely (R-Great Falls) has not yet been introduced (details were not available at time of publication).

HB 123 and HB 400 are similar; however, HB 400 would prohibit a provider who has not complied with a request for fee information to send a patient to collections or provide adverse information to a consumer reporting agency. Sen. Smith’s bill, titled the “Montana Right to Shop” for health care services, goes further in requirements and penalties for noncompliance by providers and insurers. It includes a provision that requires insurers to incentivize patients by sharing the insurer’s savings with the patient when a provider charges less than average fee paid by the insurer.

### The Budget

Until the last hours of the session, legislators will be debating the state biennium budget (July 2017 through June 2019). MDA’s lobbying has been focused on Medicaid adult dental services, which under federal law the state is not required to fund. MDA will continue to generate grassroots lobbying to target members of budget committees to preserve the dental program. MDA has signed on in support of Sen. Caferro’s bill to increase taxes on tobacco by \$1.50 per pack and a similar increase on other tobacco products to restore funding for healthcare services that was cut earlier in the session. New revenue to the state from the tobacco tax is estimated at \$43 million.

The Legislature will recess in April and reconvene later this year to address any changes made by Congress to the


